

# - Important Note for the Commonwealth of Massachusetts -

From Massachusetts Rules and Regulations 248 CMR 5.08:

- (a) For all side wall horizontally vented gas fueled equipment installed in every dwelling, building or structure used in whole or in part for residential purposes, including those owned or operated by the Commonwealth and where the side wall exhaust vent termination is less than seven (7) feet above finished grade in the area of the venting, including but not limited to decks and porches, the following requirements shall be satisfied.
- 1. INSTALLATION OF CARBON MONOXIDE DETECTORS. At the time of installation of the side wall horizontal vented gas fueled equipment, the installing plumber or gas fitter shall observe that a hard wired carbon monoxide detector with an alarm and battery back-up is installed on the floor level where the gas equipment is to be installed, in addition, the installing plumber or gas fitter shall observe that a battery operated or hard-wired carbon monoxide detector with an alarm is installed on each additional level of the dwelling, building or structure served by the side wall horizontal vented gas fueled equipment. It shall be the responsibility of the property owner to secure the services of qualified licensed professionals for the installation of hard-wired carbon monoxide detectors.
- a. In the event that the side wall horizontally vented gas fueled equipment is installed in a crawl space or an attic, the hard-wired carbon monoxide detector with alarm and battery back-up may be installed on the next adjacent floor level.
- b. In the event that the requirements of this subdivision cannot be met at the time of completion of installation, the owner shall have a period of thirty (30) days to comply with the above requirements; provided, however, that during said thirty (30) day period, a battery operated carbon monoxide detector with an alarm shall be installed.
- APPROVED CARBON MONOXIDE DETECTORS. Each carbon monoxide detector as required in accordance with the above provisions shall comply with NFPA 720 and be ANSI/UL 2034 listed as IAS certified.
- 3. SIGNAGE. A metal or plastic identification plate shall be permanently mounted to the exterior of the building at a minimum height of eight (8) feet above grade directly in line with the exhaust vent terminal for the horizontally vented gas fueled heating appliance or equipment. The sign shall read, in print size no less than one-half (1/2) inch in size, "GAS VENT DIRECTLY BELOW. KEEP CLEAR OF ALL OBSTRUCTIONS".
- 4. INSPECTION. The state or local gas inspector of the side wall horizontally vented gas fueled equipment shall not approve the installation unless, upon inspection, the inspector observes carbon monoxide detectors and signage installed in accordance with the provisions of 248 CMR 5.089(2) (a) 1 through 4.
- (b) EXEMPTIONS. The following equipment is exempt from 248 CMR 5.08(2)(a) 1 through 4.
- 1. The equipment listed in Chapter 10 entitled "Equipment Not Required To Be Vented" in the most current edition of NFPA 54 as adopted by the
- Product Approved side wall horizontal vented gas fueled equipment installed in a room or structure separate from the dwelling, building or structure used in whole or in part for residential purposes.
- (c) MANUFACTURER REQUIREMENTS GAS EQUIPMENT VENTING SYSTEM PROVIDED. When the manufacturer of Product Approved side wall horizontally vented gas equipment provides a venting system design or venting system components with the equipment, the instructions provided by the manufacturer for installation of the equipment and the venting system shall include:
- 1. Detailed instructions for the installation of the venting system design or the venting system components; and
- 2. A complete parts list for the venting system design or venting system.

- (d) MANUFACTURER REQUIREMENTS GAS EQUIPMENT VENTING SYSTEM NOT PROVIDED. When the manufacturer of a Product Approved side wall horizontally vented gas fueled equipment does not provide the parts for venting the fuel gases, but identifies "special venting systems," the following requirements shall be satisfied by the manufacturer.
- 1. The referenced "special venting system" instructions shall be included with the appliance or equipment installation instructions; and
- 2. The "special venting systems" shall be Product Approved by the Board, and the instructions for that system shall include a parts list and detailed installation instructions.

First Fire

When lit for the first time, the fireplace will emit a slight odour for a couple of hours. This is due to the curing of paints, sealants, gaskets, and lubricants used in the manufacturing process. This condition is temporary. Open doors and windows to ventilate the area. Odour caused by the curing process may cause discomfort to some individuals.

It is normal for fireplaces fabricated from steel to give off some expansion and/or contraction noises during the start up or cool down cycle. Similar noises are found with your furnace heat exchanger or cook stove oven.

> **NOTE:** Fireplace may take up to 30 seconds to ignite each time the "ON" button has been selected.

# Remote Control Operation

### **System Description**

The Proflame 2 Remote Control System consists of two elements:

- 1. Proflame2 Transmitter.
- 2. Proflame2 Integrated Fireplace Control (IFC) board and a wiring harness to connect the IFC to the gas valve and stepper motor.

### Transmitter (Remote Control with LCD Display)




Figure 1: Proflame 2 handset.




Figure 2: Proflame 2 LCD display.

The Proflame 2 Transmitter uses a streamline design with a simple button layout and informative LCD display Figure 1. The transmitter is powered by 3 AAA type batteries. A Mode key is provided to Index between the features and a Thermostat key is used to turn on/off or index through thermostat functions (Figure 1) and (Figure 2).

### **IFC Module**




Figure 3: IFC module.

The Proflame 2 Integrated Fireplace Control (IFC) module (Figure 3) is a device that allows automatic ignition and pilot flame supervision, and commands the functions of the hearth Fireplace. It's configured to control the ON/OFF main burner operation, giving the choice of both IPI (intermittent pilot ignition), and CPI (continuous pilot ignition) modes. The Proflame2 IFC module controls and connects directly to the pilot assembly and the automatic valve using low electric power.

The IFC module can be powered by both an AC power supply, and battery pack for back up. The Proflame 2 offers the added ability to control the comfort fan speed from OFF through six (6) speeds, a remotely actuated auxiliary outlet and a dim-able light outlet. The external batteries can provide DC power to the IFC allowing the batteries to be used only when line power is interrupted or lost, and if the Fireplace does not use a combustion fan.

### **Operating Procedure**

### Initializing the System for the first time




Figure 4: On-off switch.

- 1. Install 4 AA batteries into the battery holder (Figure 4) located behind the Screen/Surround, below the firebox. Make sure that the selection switch is on the "Remote" setting.
- 2. Install 3 AAA batteries into the Proflame2 Remote Transmitter (Figure 1).
- 3. Make sure there is power to the unit and open the gas supply line.
- 4. Locate the button marked "PRG" (Program) on the ON/OFF switch (Figure 4)and press the program button once. The module will beep 3 times indicating that it is ready to synchronize with a remote transmitter.
- 5. On the remote transmitter, push the power on button once. The remote transmitter will beep 4 times to indicate that the remote transmitter and the control module are now synchronized. The remote transmitter is now ready to use.

### **Temperature indication Display**




Figure 5: Display in Fahrenheit.




Figure 6: Display in Celsius.

With the system in the "OFF" position, press the Thermostat Key and the Mode Key at the same time. Look at the LCD screen on the transmitter to verify that a C or F is visible to the right of the Room Temperature display (Figure 5 or Figure 6).

### Turn on the Fireplace

With the system OFF, press the ON/OFF Key on the remote transmitter. The remote transmitter display will show some other active Icons on the screen. At the same time the Receiver will activate the Heater. A single "beep" from the Receiver (module) will confirm reception of the command.

### **Turn off the Fireplace**

With the system ON, press the ON/OFF Key on the Remote transmitter. The Remote transmitter LCD display will only show the room temperature. At the same time the Receiver (module) will turn off the Heater. A single "beep" from the Receiver confirms reception of the command.

# Manual Bypass of the Remote System (located behind the Screen Assembly)

If the batteries of the receiver or remote transmitter are low or depleted, the Heater can be turned off manually using ON/OFF switch located on battery box at the Lower Front. This will bypass the remote transmitter.

### **Key Lock**




Figure 7: Key lock.

This function will lock the keys to avoid unsupervised operation. To activate this function, press the MODE and UP keys at the same time. The lock icon will appear (Figure 7). To deactivate this function, press the MODE and UP keys at the same time.

### **Remote Flame Control**

The Proflame2 has six (6) flame levels. With the system turned on, and the flame level at maximum in the Fireplace, press the down arrow key once to reduce the flame height by one step until the flame is turned off.

The up arrow key will increase the flame height each time it is pressed. If the up arrow key is pressed while the system is on but the flame is off, the flame will come on in the high position (Figure 8). A single "beep" will confirm reception of the command.

### **ROOM THERMOSTAT (Transmitter Operation)**

The remote control can operate as a room thermostat. The thermostat can be set to a desired temperature to control the comfort level in a room.




Figure 9: Room temperature control.

To activate this function, press the thermostat key (Figure 1). The LCD display on the remote transmitter will change to show that the room thermostat is "ON" and the set temperature is now displayed (Figure 9). To adjust the set point, press the up or down arrow keys until the desired set point temperature is displayed on the LCD screen of the remote transmitter.

### **Smart Thermostat (Transmitter Operation)**

The Smart Thermostat function adjusts the flame height in accordance to the difference between the set point and the room temperatures. As the room temperature gets closer to the set point, the Smart Function will modulate the flame down. If the room temperature is cool the Smart function will modulate the flame up.




Figure 10: Smart flame control.

To activate this function, press the THERMOSTAT key (Figure 1) until the word "SMART" appears to the right of the temperature bulb graphic (Figure 10). To adjust the set point, press the up or down arrow keys until the desired set point temperature is displayed on the LCD screen of the remote transmitter (Figure 11).




Figure 12: Comfort fan control.

### **Comfort Fan Speed Control**

If the fireplace is equipped with a hot air circulating fan, the speed of the fan can be controlled by the Proflame system. The fan speed can be adjusted through six (6) speeds.

To activate this function use the Mode Key (Figure 1) to index to the fan control icon (Figure 12). Use the Up/Down Arrow Keys (Figure 1) to turn on, off or adjust the fan speed (Figure 12). A single "beep" will confirm reception of the command.

### **Accent Lights Control**

This fireplace is equipped with an overhead accent light. The auxiliary function controls this Accent Light.

To activate this function, use the Mode Key, (Figure 1) to index to the AUX icon (Figure 13). Pressing the Up Arrow Key will turn the light on. Pressing the Down Arrow Key will turn the light off (Figure 14). A single "beep" will confirm the reception of the command.

# **Continuous Pilot/Intermittent Pilot (CPI/IPI)** selection

With the system in "OFF" position press the Mode Key (Figure 1) to index to the CPI mode icon (Figure 15). Pressing the Up Arrow Key will activate the Continuous Pilot Ignition mode (CPI). Pressing the Down Arrow Key will return to IPI. A single "beep" will confirm the reception of the command.

### LOW BATTERY POWER DETECTION

### **Transmitter**

The life span of the remote control batteries depends on various factors: quality of the batteries used, the number of ignitions of the appliance, the number of changes to the room thermostat set point, etc.




Figure 16: Low battery icon.

When the Transmitter batteries are low, a Battery Icon will appear on the LCD display of the Transmitter (Figure 16) before all battery power is lost. When the batteries are replaced this Icon will disappear.

### Receiver

The life span of the IFC batteries depends on various factors: quality of the batteries used, the number of ignitions of the appliance and the number of changes to the room thermostat set point, etc. When the IFC batteries are low, a "double-beep" will be emitted from the IFC board when it receives a command from the transmitter. This is an alert for a low battery condition for the IFC board. When the batteries are replaced the "beep" will be emitted from the IFC board when a key is pressed. See "Initializing the System for the first time" on page 8.

# Warnings and Cautions

### **WARNING**

Fire Hazard. Can cause severe injury or death

The Receiver causes ignition of the appliance. The appliance can turn on suddenly. Keep away from the appliance burner when operating the remote system or activating manual bypass of the remote system.

### WARNING

Shock Hazard. Can cause severe injury or death

This device is powered by line voltage. Do not try to repair this device. In no way is the enclosure to be tampered with or opened. Disconnect from line voltage before performing any maintenance. Turn off gas and electrical power supply (if applicable) and allow ample time for unit to cool before servicing appliance. It is recommended that the fireplace and its venting should be inspected at least once a year by a qualified service person.

### Glass Door:

**Warning:** Do not operate fireplace with glass door removed, cracked or broken. Replacement of the glass door should be done by a licensed or qualified service person. Check glass panel gasket, replace if necessary. It is important that the glass seal be maintained in good condition.

Do not strike or otherwise impact the glass in any way that may cause it to break. If the glass becomes cracked or broken it must be replaced before using the fireplace. Replacement door can be obtained from your nearest Pacific Energy dealer. Do not substitute with any other type. To remove broken glass, remove Door as noted in "Door Removal" section.

### **Annual Inspection:**

- a) Remove glass door and decorative media (such as Glass, logs and Embers). Inspect decorative media and burner assemblies for soot buildup. If excessive buildup of soot is present, have a qualified service person inspect and adjust unit for proper combustion. Clean burner with a brush or vacuum cleaner, paying close attention to burner ports.
- b) Check the pilot system for proper flame size and operation. Clean pilot free of soot, dust or any other deposits.
- c) Check that the vent pipe and vent terminal are open and free from blockage or debris. If the venting is disassembled for cleaning, it must be properly assembled and re-sealed. Refer to VENTING section for proper procedure.
- d) Check and replace batteries as needed.

**Note:** The appliance area must be kept clear and free from combustible materials, gasoline and other flammable vapors and liquids.

### Periodically:

- a) Viewing glass may be cleaned as necessary with glass cleaner. For touch stains use a fireplace (ceramic) glass cleaner.
- b) Exterior finish may be cleaned with mild soap and water.

**CAUTION:** Do not use abrasive cleaners on glass or any other part of the fireplace.




Figure 17: Z25 Dimension views.

# Locating the Fireplace

In planning the installation for the fireplace, it is necessary to determine where the unit is to be installed, location of vent system and where gas supply piping may be plumbed. Various installations are possible, such as, into an existing wall, a corner, a built in wall or a wall projection. Due to high temperatures, do not locate this fireplace in areas of high traffic or near furniture or draperies. The fireplace should be accessible for service




Figure 18: Z25 Installation examples.




Figure 19: Z25 Venting Location Dim.



# Top to Rear Vent Conversion




Figure 20: Vent Conversion 1.

- To convert the vent from top to rear outlet, remove the outer collar by removing the 5 Torx T20 screws (Figure 20).
- Remove the 5 screws holding the cover plate (Figure 21)




Figure 22: Vent Conversion 3.

# **Framing and Finishing**

### **Notes:**

We recommend that the fireplace should be in place and venting installed before framing in or building an enclosure around the unit.

The Z25 fireplace must be framed in as described in the following section or totally enclosed with non-combustible material, such as facing brick.

The sides, back and top of the fireplace can be framed in using conventional lumber. Consult local building codes for specific requirements.

A header using 2 x 4's must be installed on top of the steel framing kit, so that the front edge of the header is flush with the steel framing kit (Figure 30).

### The finishing material must not interfere with glass door and safety screen removal.




Figure 25: Z25 framing enclosure.

Due to high temperatures, non-combustible material board, such as cement board or its equivalent, must be used to sheet in above the fireplace. The top of the non-combustible board must extend a minimum of 21-5/8" [55cm] above the fireplace opening or level with the top of the steel framing kit- (Figure 25 on page 20). The non-combustible board can continue past this point if desired. Standard sheet rock (dry wall) may be used up to the sides of the fireplace opening.

It is recommended that the top section of the non-combustible board be a single sheet. Taped and mudded joints may crack due to the elevated temperatures.

Chase Insulation: When installing this fireplace against a non-insulated exterior, wall or chase, it is recommended that the outer walls be insulated to same degree as other exterior walls. Do not place the fireplace directly against the insulation or vapor barrier. Cover the insulation and plastic vapor barrier with a solid surface, such as dry wall (sheet rock). Consult local codes. Do not insulate the front of the chase between the top of the fireplace and the top of the supplied steel studs.




Figure 26: Facing Support Screws.




Figure 27: Framing Kit Assembly.





Figure 28: Framing Kit to Support.




Figure 29: Z25 Framing front view.





Figure 31: Z25 mount to Framing.




Figure 33: Z25 LP venting chart.




Figure 34: z25 Venting configurations.






Figure 38: ICC TM-5HT Horizontal terminal.

# Electrical Connection

### **Electrical connection**




Figure 40: Z25 House wire connection.

The incoming power supply to this fireplace is to be connected to the units wiring harness using wire nuts. Located on the left-hand side of the fireplace (Figure 39) is a strain relief, pass the house wire through the strain relief. Connect the house wire to the wires inside the fireplace using wire nuts (Figure 40). The ground wire from the house wire and the unit harness must be connected to the Ground Post (Figure 40). Electrical connections should be performed by a qualified electrician as per local electrical codes.

Servicing of the appliance can be performed from the front of the unit.

Caution: The gas line should be installed by a qualified service person in accordance with all building codes. This section is intended as a guide for qualified technicians installing this appliance. Consult local and/or national Gas/Building codes before proceeding.

- The Gas Supply Shut-off and connection is located on the right side of the fireplace. The Shut Off Valve accepts a 3/8" NPT fitting.
- Correct gas supply line diameter must be used to assure proper operation and pressure. The fireplace input rating is shown in the chart on page 33.
- A drip leg must be installed in the gas supply line going to the gas control valve to minimize the
  possibility of any loose scale or dirt within the gas supply line from entering the control valve.
- The valve is shut off when handle is in the "down" or "across" position.

Check local codes for additional requirements. Turn on the gas supply and check that all connections are tight and leak free. Bleed the lines and start the unit for the first time, with the door removed.

# Gas Leak Detection -

A gas leak sniff test should be performed after a gas connection, gas valve or pilot assembly has been replaced or serviced. There are many different makes and models of detectors. A unit which can detect natural gas and propane must be used. Follow the gas leak detector manufacturers instructions on how to properly use the detector.

CAUTION: The electrical power to the fireplace should be disconnected at the circuit breaker before and during any gas valve or gas connection servicing or replacement. Do not reconnect the electrical power to the fireplace until after the gas leak detection test has been completed and the presence of a gas leak has been ruled out.

# Propane Conversion

### WARNING

This conversion kit shall be installed by a qualified service agency in accordance with the manufacturer's instructions and all applicable codes and requirements of the authority having jurisdiction.

If the information in these instructions is not followed exactly, a fire, explosion or production of carbon monoxide may result causing property damage, personal injury or loss of life.

The qualified service agency is responsible for the proper installation of this kit. The installation is not proper and complete until the operation of the converted appliance is checked as specified in the manufacturer's instructions supplied with the kit.

### **CAUTION**

The gas supply and electrical power shall be shut off before proceeding with the conversion.

Note: Factory supplied components must be used to ensure correct input. After conversion confirm proper manifold pressure.

Ensure the burner, pilot and gas supply are turned off, and the appliance has cooled.

With the burner removed, use a ½" deep socket to remove the natural gas orifice (Figure 43) from the venturi box and replace with propane orifice part:

#ET for units vented out the rear with Glass Burner. or #ES for all other configurations.




Figure 46: Band in liquid propane position.

- 2. Slide the pilot adjustment band over (Figure 45) and ensure that the hole in the orifice band is showing. Figure 46 indicates that the pilot is in the Propane Gas position.




Figure 48: wiring 2.




Figure 50: CONVERSION KIT LABEL.

# Gas Pressure Testing Procedure

Note: Verify gas pressures with the fireplace lit and at the highest setting.

WARNING: turn off the gas supply at the appliance before loosening the test port screws.

- 1. Remove the window screen / surround and locate the valve and the shut off valve.
- 2. Turn the gas OFF using the gas shut off valve.




Figure 51: SIT gas control valve.

- 3. Locate the Inlet and Manifold test ports on the valve. (Figure 51). Using a screwdriver, loosen the screw in the port you want to test. Attach a tube, connected to a pressure gauge to the test port.
- 4. Turn gas supply back on and verify the pressure.
- 5. After testing is finished for that port, turn off gas supply, remove the pressure gauge and tighten up the screw in the test port.

# **Facing and Finishing**




Figure 52: Z25 Finishing wall board.

When finishing in the wall at the front of the Z25, there are 2 zones: Dry-wall or other combustible facing materials can be used in the combustible materials **zone 1**(Figure 52). The non-combustible **zone 2**(Figure 52) must use non-combustible materials and finishes, such as masonry or calcium silicate board and tile or stone facing materials.




Figure 53: Z25 Finishing trim removal.

- Remove the 4 screws holding the adjustable Finishing Trim in place (Figure 53). The trim can accommodate wall finishes from 1/2" to 1-1/4 (12mm to 32mm).
- Facing material may be 1/4" to flush with the inside edges of the fireplace casing. Do not place any material over the opening around the door.
- Reminder: in the area directly above the fireplace opening (zone 2), only non-combustible material may be used.
- Once the wall facing has been completed, re-install the Finishing Trim against the wall and tighten the screws.




Figure 54: Z25 clearances to combustibles.




Figure 55: Remove glass media




Figure 56: Remove glass media tray.




Figure 57: Remove single screw on right side of burner.




Figure 58: Remove screws on left side of burner.




Figure 59: Disengage burner from the Primary Air shutter.




Figure 60: Remove the screw on the main section of the access cover.




Figure 61: Remove the screws for the Pilot Assembly.





Figure 62: Remove the screws on the back of the access cover.




Figure 67: Tuck wires and gas tubes in front of blower assembly.




Figure 69: Media Tray removal 1.




Figure 70: Left Side.




Figure 72: Back Panel 2.

### Safety Screen Removal/Installation —






Figure 79: Screen Mounting Slot.




Figure 83: Door Hinge location.




Figure 84: Z25 Venturi adjustment.

The Z25 fireplace venturi adjustment is easily accessible and adjustable without having to remove the glass door.

To adjust the burner venturi:

- 1. With the fireplace turned off, check that the front surround is cool to the touch.
- 2. Remove the front surround from the fireplace.
- 3. With the fireplace turned on, use the adjustment screw, located under the door on the right hand side (Figure 84) to adjust for flame appearance. Rotating Clockwise closes the damper and Counterclockwise will open it.

#### Note:

The venturi settings on the fireplace come preset from the manufacturer. The unit comes configured for natural gas with the venturi adjustment set at the fully closed position. When converting to propane gas set the venturi adjustment at the fully open position. It may be necessary for the installer to make a minor adjustment, whether using a natural gas or a propane, to achieve the desired flame pattern and/or to eliminate sooting.

Installation of the Damper Kit depends on the venting and final location of the terminal. Remove the Screen and Door assemblies per instructions.

• The angled back shield of the firebox is a removable part. Remove the 4 screws across the top of the panel. Pull the panel gently towards you to release it from the retainers on the back of the




Figure 86: Flue opening.

- Adjust the damper by loosening the two bolts (3/8) and sliding the damper plate to the desired marked notch. These numbered notches correspond to the Venting Charts "Figure 32: Z25 NG venting chart." on page 23 and "Figure 33: Z25 LP venting chart." on page 24.
- Tighten the bolts.




Figure 89: Damper Notches.

• Re-install the rear shield by sliding it back into the retainers on the back of the unit then tilting the front up and installing the 4 screws across the top.

Note: Be aware that the damper adjustment mechanism may be hot if the fireplace has been burning for any length of time.




Figure 90: Control mount screw.




Figure 91: Control Cover screw.




Figure 93: z25 Mounting Tabs.




Figure 94: z25 Mounting Slots.

### Halogen Lamp Replacement

This fireplace comes with a Halogen Lamp which may need to be replaced on occasion. To access the bulb:

- 1. Remove the safety screen from the fireplace, see "Safety Screen Removal/Installation" on page 41.
- 2. Remove the glass door. See "Door Removal/Installation" on page 42.
- 3. Remove the 2 screws holding the light shield in place (Figure 95).
- 4. Remove the 2 bolts holding the Lens Cover (Figure 96), Be careful when removing as the glass lens is loose in its holder.
- 5. Remove the old lamp by gently pulling it out of its socket (Figure 97).

- 6. Wear gloves when installing a new lamp, touching the lamp with bare fingers will leave oil and residue on the lamp and can reduce the lamps' life span.
- 7. Make sure the gasket is in good condition. The gasket goes between the firebox top and the glass then the cover holds the glass against the gasket. Re-install the bolts and hand tighten.
- 8. Re-install the Shield, the glass door and screen before operating the unit.





Figure 98: SIT wiring diagram.
